WHAT IS PLANNED GIVING?

A planned gift is made during your lifetime or upon death to benefit an organization of your choice. Planned giving is different from cash gifts as it often allows you to make a larger gift than from income alone.

You may arrange for the foundation to receive:

- · a gift with a set dollar amount
- life insurance, retirement plan or stock payouts
- certain assets, including real estate or tangible personal property
- all or a percentage of your estate after all other obligations are paid

Planned gifts shared with the foundation remain confidential unless the donor agrees to be acknowledged publicly.



HOW WILL THE FOUNDATION USE MY GIFT?

Planned giving donors may specify that their gift be used for a special project or purpose, or it may be unrestricted so the foundation can use it where it is most needed.

Those who make planned gifts become members of the Silas Pinney Society, which recognizes and honors individuals who are comfortable with their bequest being publicly recognized. Mayor Silas Pinney is credited with the 1875 founding of Madison's first free library.

HOW DO I MAKE IT OFFICIAL?

The most important thing you need to do if you choose to make a planned gift is to inform the foundation of your intention. We can then work with you and your attorney or advisor to ensure your gift is used as you intend.

Every adult should have an estate plan in order to transfer their assets in a thoughtful and conscious manner. An estate plan often includes a will or living trust, as well as beneficiary designation forms for certain assets, such as insurance policies and retirement plans. A discussion with an attorney who specializes in this area will give you an idea of the planning you need to do to ensure that your wishes are fulfilled.
